The Story Behind My Career

My journey has been defined by “institutional turnarounds”; taking organizations or initiatives that have stalled and injecting them with new vision and viability. This path led me to spearhead global initiatives that align private

sector innovation with public sector security.

My Background and Values

I am driven by a philosophy of “innovation, resilience, and diplomacy.” As a businesswoman who navigated the complexities of global trade before entering the policy arena, I value practical, tangible results over theoretical debate. I believe that justice and commerce are not opposing forces; rather, fair commercial frameworks are the bedrock of lasting peace. My Unique Methodology

This is the methodology behind “The Washington Compact,” where we convened industry leaders to agree on standards for commercial space operations, creating a functional rule of law that moves at the speed of innovation, rather than the speed of bureaucracy.

The most critical trend today is the fragmentation of international norms. As global powers retreat into protectionism, multinational entities face a patchwork of conflicting regulations. I see a shift away from universal, top-down treaties toward “minilateral” agreements and coalition-based standards. For my clients, this means that regulatory compliance is no longer a checklist – it is an active diplomatic campaign.

The Philosophy Guiding My Work

I believe in “Permissive Governance.” Rules should not be barriers; they should be guardrails that give innovators the confidence to proceed. My work is guided by the conviction that clarity creates investment. By establishing clear, fair, and agreed-upon norms, we unlock capital and human potential.

How I Solve Complex Problems

I act as a translator between distinct worlds. I speak the language of the CEO who needs ROI and the language of the Diplomat who needs stability.
